Mekorot Water Company Ltd. hereby requests to receive proposals for the supply of two (2) Interstage turbocharger systems which includes: pump side fluid - pump with the capacity of 200 cubic meters per hour and turbine side fluid – turbine with the capacity of 100 cubic meters per hour for the Zion Cohen (LAHAT) BWRO Desalination Plant and all as prescribed in this document including design, manufacturing, testing, packaging, supply, supervision for installation, operation, conveyance and unloading, and all as prescribed in the document of this Tender.

As a part of the register process the Bidders shall be required to enter SourcingVision system with the Username and Password which sending by e-mail from SourcingVision system to be able to apply an offer. In addition to the tender documents also the notices and clarifications will be available for review and downloading at SourcingVision system.

**Thresholds**

Bidders who received the proceeding documents and comply with all the thresholds specified below, are permitted to submit their proposals, evidenced by presentation of the appropriate documents according to the specification in this section:

1. The bidder is required to be the manufacturer of the Interstage turbocharger systems or a supplier who represents an Israeli manufacturer or a foreign manufacturer. If the bidder is not the very manufacturer, then it is necessary to enclose an approval of the manufacturer, stating that the bidder is the representative of the manufacturer in Israel and is authorized to market the Interstage turbocharger systems of the manufacturer. If the bidder is the manufacturer of the Interstage turbocharger systems, the requirement is to have a representative in Israel, approved thereby. Approval and particulars of the representative in Israel must be submitted.
2. The manufacturer of the Interstage turbocharger systems is required to have a proven experience of manufacturing and supply of Interstage turbocharger systems in the quantity of at least 3 Interstage turbocharger systems throughout the last 7 years ending at the final date for submitting the proposals. For proving compliance with this threshold, please enclose a list of clients verifiable by Mekorot, including the specification of the sold Interstage turbocharger systems, the site where they have been installed and contact persons and their positions, telephone numbers and e-mail addresses.
3. The Interstage turbocharger systems manufacturer must have ISO 9001certified. For evidencing compliance with this threshold, please enclose a valid confirmation.
4. The bidder is required to be an authorized dealer who fulfills the duty of bookkeeping and tax payments as required by law. For the purpose of proving compliance with this threshold, please enclose to the proposal suitable and valid approvals in accordance with The Israeli Transactions of Public Entities Law, 1976, as follows:

an authorized dealer certificate, approval of management of account books and records under The Israeli Transactions of Public Entities Law, approval for tax deduction, and affidavits duly signed in the form enclosed to this tender as appendices 1 and 2. This term applies only to an Israeli bidder.

### **Submitting proposals in the proceeding**

The proposal shall be submitted solely "SourcingVision" system as prescribed above.

### **The bids must be submitted not later than 7 November, 2019 at 12:00noon.**

Mekorot shall notify bidders of any change in the times for submitting bids. Bids submitted in any other way will not be accepted. Bids submitted after the deadline set forth above will not be accepted.
