## for the supply of DN2400, PN32 Dismantling Joint for KISALON PUMPING STATION, No. 2

Mekorot Water Company Ltd. hereby requests to receive proposals for the design, manufacturing, testing (in the factory of the manufacturer), supervision for installation (in Israel), packaging, delivery to terminal based on FOB IncoTerms2010 or transport and offloading of the Dismantling Joint, by the bidder, at Mekorot's site in Israel, of a DN2400, PN32 Dismantling Joint for KISALON PUMPING STATION, No. 2.

The installation of the Equipment will be done by Mekorot and/or by anyone on its behalf according to the supplier's instructions and supervision for installation in KISALON PUMPING STATION, No. 2.

**Permitted to submit proposals** are bidders that meet all threshold conditions listed below, as evidenced by presenting the appropriate documents in accordance with the details in this section:

- The bidder must be the Dismantling Joints manufacturer or a supplier who represents an Israeli or foreign manufacturer. If the bidder himself is not the manufacturer, the bidder shall attach to his proposal a confirmation letter from the Dismantling Joints manufacturer confirming that the bidder is authorized to offer the manufacturer's Dismantling Joint.
- The Dismantling Joints manufacturer must have a proven experience in:
   manufacturing and supply of DN1600, PN16 Dismantling Joints and in a quantity of at least <u>3</u> Joints;
   <u>and also</u>

manufacturing and supply of DN1000, PN40 Dismantling Joints and in a quantity of at least **2** Joints; all of the said experience is <u>over the last 5 years</u>, completed by the deadline for submitting bids in this tender.

To prove this threshold condition, the bidder shall submit a list of customers that can be verified by Mekorot, including details of the Dismantling Joints sold (measurements, quantities and the dates they were supplied), the sites they were installed in and the contact persons and their position, phones and email addresses.

• The bidder must be a licensed dealer complying with financial management and tax payment obligations. Appropriate and valid documentation must be enclosed under the Public Entities Transactions Law 5736 – 1976 as well as affidavits duly signed in the wording like the text attached as Appendix 1 and 2 to this tender – this condition applies only to Israeli bidders.

The bids must be submitted not later than November 28, 2018 at 12:00noon (at Israel's local time), to the Email address: OfficeBox@Mekorot.co.il. Individual e-mail is limited to mail a maximum size of 3MB (for larger data it is advised to split the offer in different e-mails).

Mekorot shall notify bidders of any change in the times for submitting bids. Bids submitted in any other way will not be accepted. Bids submitted after the deadline set forth above will not be accepted.
